PUBLIC NOTICE

Notice for inviting e-tenders for re-allotment of 4 licensees for Retail sale vends (L-2/L-14A) from the general public for the remaining Excise Policy 2022-23 (19th December 2022 to 31st March 2023) in U.T., Chandigarh.

1. It is hereby notified the information of general public that e-tenders are invited for the grant of retail sale i.e. L-2/L-14A licenses in the form of licensing units for the remaining Excise Policy, 2022-23 (19th December 2022 to 31st March 2023). Each Licensing Unit will comprise L-2/L-14A (Indian Made Foreign Liquor, Imported Foreign Liquor and Country Liquor) under one roof. There are 4 licensing units for re-allotment across the entire city and e-tenders shall be invited individually for all the licensing units.
2. The Retail-sale vends shall be allotted to the highest eligible bidder, quoting equal to or above the reserve price of the licensing unit. In case of more than one bid quoting the same highest price is received, the allotment shall be determined by draw of lots among the bidders quoting the same highest price.
3. All willing participants may visit the official website of the department i.e. www.etdut.gov.in/exciseonline for information to know the procedure. The detailed procedure for e-tenders and submission of participation fee and earnest money, in accordance with the Excise Policy 2022-23, is available on the official website of the department i.e. www.etdut.gov.in/exciseonline as well as in the Excise office of the Department.
4. In order to submit e-bids, every prospective bidder is required to get himself registered at <https://etenders/chd.nic.in>
5. The terms & conditions and the detailed list mentioning localities/sectors of Licensing units, Vend Code, permissible no. of vends, quota and reserve price can be downloaded from the official website of the Excise & Taxation Department i.e. www.etdutgov.in/exciseonline from 'Public Notices' Section.
6. All licenses shall be granted subject to the Punjab Excise Act, 1914 (as applicable to U.T. Chandigarh) and the Rules framed there-under and the Excise Policy 2022-23. The Excise Policy 2022-23 is available on the official website of the Department www.etdut.gov.in/exciseonline.
7. E-tenders will be available at <https://etender.chd.nic.in> on 19.12.2022 at 11:00 am and the bidders may start to submit their bids form from 19.12.2022 (11:00 am onwards).
