Sub: Constitution of Anti-Profitteering Screening Committee at the Union Territory level (Chandigarh) -reg.

As per Section 2 (103) of the CGST Act, 2017 "State" includes a Union Territory with a legislature. "Union Territory" has been defined under Section 2 (114) of the CGST Act, 2017. But the Union Territory of Chandigarh does not have legislature and it does not fall within the above definition of "State" and hence, Screening Committee of Union Territory of Chandigarh cannot be constituted under Rule 123 (2) of the CGST Rules, 2017. However, as Union Territory of Chandigarh is administered by the Central Government, anti-profitteering applications from Union Territory of Chandigarh involving even issues of local nature can be directly examined by the Standing Committee on anti-profitteering. In such cases, the jurisdictional Chief Commissioner of GST shall act as the nodal officer who will receive such applications and forward them to the Standing Committee.
